An affordable resolution

To help you craft an energy-efficiency resolution, put weatherstripping at the top of any list of affordable electricity resolutions:

Weatherstripping offers a relatively quick fix for drafty doors—and air leakage is a primary culprit for most home energy losses.

A fast way to check for a leak around a door is to look between the door and its frame or the floor. If you see even a sliver of daylight, add weatherstripping.

Here are a few weatherstripping basics:

Read the instructions on the package; apply only to clean, dry surfaces above 20 degrees Fahrenheit; measure twice before cutting anything; apply weatherstripping in one continuous strip; apply snugly against both surfaces; material should compress when the window or door is shut.

LEARNING FROM APES

High School Juniors Study American Private Enterprise System



Last November, 45 local students participated in a two-day education seminar that allowed them to learn about corporations, cooperatives, individually owned businesses, legalities of business, and diversity. These elite students consistently scored high on quizzes and a 50-question final exam. At the end of the program, six of the teens were awarded a trip to the State Youth Seminar in Lexington this June.

APES, which stands for American Private Enterprise System, offers eight students from each Hardin County High School (E-town High, Fort Knox, North, Central, and John Hardin), as well as two students from the home school sector and North Hardin Christian School, the opportunity to come together at an off-site location to learn about business and the free enterprise system. The program has

been around more than 40 years, and has gained a reputation among students as being one of the top five things to put on a resumé.

Nolin RECC has been a sponsor of the Hardin County, as well as LaRue County, APES program since it began. In fact, electric cooperatives throughout Kentucky are helping to sponsor APES programs in about 35 different counties.

The APES program helps to build self-confidence and leadership skills. The teens are encouraged to network with students from other schools as they work together in groups.

One popular exercise is the board case studies. This session allows participants to examine real-life issues that may arise in a business. Students are divided into board groups (each representing a director of the board) and are given situations to

study and resolve. The teams must follow a set of business decision steps in hopes of achieving the best possible result. Students conclude this exercise by presenting board resolutions to their peers and then must face opposing boards as they explain and support their decisions during the debate session.

Kerby Grey Receives Kentucky Young Farmer Association Member of the Year

Power lines are KILLERS

Winter weather and car accidents account for the majority of downed power lines, according to the Electrical Safety Foundation International.

Always assume that any downed line you see is an energized power line and report it immediately to the police, fire department, and Nolin RECC.

If you discover a low or downed line, make sure you do the following:

- Move away from the line and anything touching it.
- If you see someone who is in direct or indirect contact with the line, do not touch the person. You could become the next victim. Call 911 instead.
- Do not attempt to move a line or anything in contact with it by using an object such as a broom or stick. Even nonconductive materials like wood can conduct electricity if slightly wet.
- Be careful not to put your feet near water where a downed power line is located.
- If you are in a vehicle that has contact with a line, stay inside. Use your cell phone to call for help. Honk your horn to keep others away.
- Do not drive over downed power lines.

Operating large farm equipment near overhead lines poses another hazard. Everyone working on a farm should be aware of power lines and keep farm equipment away from the lines. Take special note of larger, modern equipment such as tractors with high antennas.

Nearly one year ago, Cecilia farmer Kerby Grey received word he had been selected as the Kentucky Young Farmer Member of the Year. He was presented the distinction by Kentucky's Touchstone Energy Cooperatives and other sponsors at the Kentucky Young Farmer Association's State Convention in Lexington in February of last year.

The award is based on the individual's overall farming enterprise, including financial, record keeping, and innovative advances.

Grey was surprised to hear about his advancement to the semi-finals. "When I received word last February about making the semi-finals, I was really happy and thought even if I didn't advance to the finals, it was still an honor," says Grey. "I was really surprised to learn I had been named Young Farmer Association's Member of the Year."

Grey farms full-time on his 2,200 acre grain farm in Cecilia raising corn, soybeans, and wheat. The farm is the same one he and his three siblings grew up on with parents Clayton and Geraldine Grey.

"When I was a boy, I would help my dad on the farm and after graduating in 1990 from West Hardin High School, I went to work full-time as a farmer," says Grey. Today, the elder Grey helps out on the farm from time to time when needed. And of course, Kerby says he always seeks advice from his dad on important farming matters.
