#### Is rooftop solar right for you?

In addition, there are other considerations that are essential if a member want to install a home energy system:

• It is important that a member get in contact with Nolin before they install a system, as this will allow Nolin to ensure that the system is properly connected to the grid and the member gets credit for any excess electricity they produce.

• Our Net Metering Tariff has important information on interconnecting a renewable energy source. It can be found on our website www.nolinrecc.com. This tariff agreement must be completed and approved prior to beginning installation.

• Prior to installing a renewable energy system, members are responsible for obtaining any necessary permits from Planning & Zoning. When a member contacts Nolin, our energy advisors will provide perspective on the total energy puzzle. Taking into account current energy consumption, the home "envelope," age and efficiency of the HVAC system and home site, an energy advisor can help a co-op member determine whether rooftop solar is the best choice given the homeowners' objectives.

When assessing solar options, it is an excellent time to examine other potential energy efficiency improvements for your home. For example, it may make sense to insulate the attic or seal openings in the home.

Nolin recognizes that member interest in renewable energy sources is increasing, and we stand ready to help our members. We also offer programs like Cooperative Solar that provide an alternative to

Rural communities in the area were finally receiving electricity to their farms, homes and businesses years after many of their urban neighbors. The groundwork had been laid during the previous year by local residents who joined together to form our cooperative—and by July 1, 1939, the lights came on.

# Spending time outdoors? Stay safe around electricity

After a long winter of staying indoors more than usual, outdoor fun is calling.

Keep yourself and your family safe by paying attention to your use of electricity outdoors. Some tips:

• Have an electrician check outdoor electrical outlets to make sure they are protected with groundfault circuit interrupters that automatically shut the power off in case of contact with water. Outdoor outlets on older homes might not have this critical safety feature. • If you must use an extension cord outdoors, buy a thick, weatherresistant model rated for outdoor use. Don't string cords together and don't leave them outdoors when you're not using them.

• Choose a wooden or fiberglass ladder when you are working near electrical wiring or electric lines. Metal can conduct electricity and shock anyone who is standing on a ladder if it comes into contact with a power source.

• Don't use your electric grill



outdoors if it's raining—even a little.

• Inspect electrical lawn tools for frayed wires and other damage. Don't try to repair the damage; replace the tool.

# Stay safe over Fourth of July

Make your holiday a safe one for your family by following some commonsense rules for celebrating with and near electricity. **1. Keep fireworks far away from overhead power lines.** If fireworks are legal in your community and you choose to set them off yourself, keep them at least 10 feet away from power lines and 35 feet away from high-voltage wires.

2. Keep an eye on your grill. Whether it's electric, gas or charcoal, do not leave a hot grill unattended, even for a few



minutes. Its intense heat can easily harm children or pets. Plus, if flames are involved, you need to be there if they get out of control. Cooking accidents are the leading cause of house fires. **3. If you need an extension cord to plug**  in your grill or another cooking appliance, do not use that cord on more than one device at a time. And do not plug extension cords into each other; they're not designed for that. They can overheat and cause a fire.
4. Keep the grill, blender, TV and other appliances away from the pool and from all water sources. Even if you're a safe distance away from the

water, unplug the appliance as soon as you're finished using it.

5. Have a working fire extinguisher on hand.
